**Required Information:**

***Menu:***

- Vendor must attach a complete menu of items, including prices, to be sold.
- Vendor may sell only food and beverage items, and all items must be approved.
- Submit \$100 payment with application.

***License and Insurance:***

- Vendor must attach a copy of current food vendor permit.
- Vendor is responsible for complying will all Health Department requirements.
- Vendor must provide proof of insurance, in the form of a certificate of liability insurance, naming the SCV, INC as an additional insured.
- Vendor is responsible for complying will all codes and laws of the City of Columbia.
- Vendor is responsible for their own insurance.

***Booth Space and Vendor Responsibility:***

- Vendor will be assigned a defined area in which to operate (by Rusty Sutler Committee).
- All tents, attachments, generators, coolers, awnings trailer tongues, tables and chairs must fit in the assigned space.
- Parking outside of the defined and paved areas is prohibited, except for the purpose of setup or teardown before or after the event.
- Vendor is responsible for providing all items pertaining to the business, including but not limited to, tent, tables, chairs, etc.

-No smoking is permitted in or around the booth.

-Vendor may only sell from defined area. No roaming and selling is permitted, unless authorized in advance.

***Electricity and Water:***

-Electrical hookups are not available. Generators are permitted.

-Direct water hookup is not available.

-Vendor is responsible for covering and/or taping down all cords, awnings, tents, etc. according to safety code.

-Ice is not available.

***Rain and Weather:***

-There are no refunds for rain or any other weather condition, unless the entire event is canceled.

***Display of Permit:***

-Permit must be displayed at all times during the event.

***Agreement:***

Hold Harmless Clause: Applicant shall save and hold harmless SCV, Inc. and the Rusty Sutler event staff and volunteers harmless from and against all liability, claims and demands on account of personal injuries (including without limitation to the foregoing worker's compensation and death claims) or property loss or damage of any kind whatsoever, which arises out of or be in any manner connected with the performance of this contract, regardless of whether such injury, loss, or damage shall be caused by, or be claimed to be caused, by the negligence of the permit holder or the SCV, Inc. and the Rusty Sutler; or by any agents or employees of any of the foregoing; or by accident; or otherwise.
